

Directions to Reckner: White Plains, NY
3 Gannett Drive, Suite G-9, White Plains, NY 10604

When using the address for a GPS device, enter the city as West Harrison, NY

From I-95

Take I-95 to 287 West (Exit 21) heading towards White Plains. Take Exit 9 N-S and stay in the lane(s) marked Westchester Avenue. Pass through 2 traffic lights and turn right onto Gannett Drive (before third light). Once on Gannett, take the first right, following sign for #3 Gannett. Take the first left into the main parking lot at the front of the building. Once inside the building, turn to the right and look for Suite G-9.

From Manhattan

Take FDR Drive North to the Bruckner Expressway/I95 North/New England Thruway. Follow I95 North through the Bronx into Westchester County. Take Exit 21, merging onto 287 West heading towards White Plains. Follow directions for I-95 above.

From Connecticut on the Merritt Parkway

Merritt Parkway south to exit 26W/ 287 West. Exit will automatically put you on Westchester Avenue. Turn right onto Gannett Drive. Once on Gannett, take the first right, following sign for #3 Gannett. Take the first left into the main parking lot at the front of the building. Once inside the building, turn to the right and look for Suite G-9.

From Westchester County Airport/Northern Westchester

Travel south on route 684. Exit 287W / Westchester Avenue. Ramp will split-Bear right onto Westchester Avenue. Make your first left onto William L. Butcher Bridge. At the traffic light turn left onto Westchester Avenue (heading east). At the second traffic light make a left onto Corporate Park Drive. Go over the bridge and take a left back onto Westchester Ave (heading west). Take your first right on to Gannett Drive. Once on Gannett, take the first right following sign for #3 Gannett. Take the first left into the main parking lot at the front of the building. Once inside the building, turn to the right and look for Suite G-9.

Traveling From LaGuardia Airport and Lower Westchester

Upon leaving the airport follow signs for Grand Central Parkway East. Follow signs leading you over the Whitestone Bridge. Once you have paid the toll bear to the left onto the Hutchinson Parkway North. Travel on Hutchinson Parkway to Exit 26W / 287 West. The ramp will automatically put you on Westchester Avenue heading west. Turn right onto Gannett Drive (before light) and once on Gannett, take the first right, following sign for #3 Gannett. Take the first left into the main parking lot at the front of the building. Once inside the building, turn to the right and look for Suite G-9.

Traveling from the Garden State Parkway

Follow signs for the Tappan Zee Bridge and Route 287 East. Go over the Tappan Zee Bridge, and after paying toll bear to the left. Follow the signs for 287 E. Merge onto I-287 E/Cross Westchester Expressway. Take the I-684/Weschester Ave exit number 9A. Take Westchester Ave to Corporate Park Drive and turn left, going over the bridge. At the light, take a left back onto Westchester Ave (heading west). First right onto Gannett Drive (before light), and first right at 3 Gannett Drive. Take the first left into the main parking lot at the front of the building. Once inside the building, turn to the right and look for Suite G-9.
